### NATUREWALK COMMUNITY DEVELOPMENT DISTRICT

The meeting of the Board of Supervisors of the NatureWalk Community Development District was held on **Thursday**, **May 1**, **2025**, **at 12:00 p.m.** at the Walton Area Chamber of Commerce, located at 63 South Centre Trail, Santa Rosa Beach, FL 32459.

### FIRST ORDER OF BUSINESS

Call to Order

Ms. Bailey called the meeting to order at 12:01 p.m. and confirmed there was a quorum.

### SECOND ORDER OF BUSINESS

### **Audience Comments**

Ms. Bailey noted that Audience Comments were being deferred to later in the meeting to allow the District Engineer to present a significant report to the Board of Supervisors.

### THIRD ORDER OF BUSINESS

Consideration of the Minutes of the Board of Supervisors (BOS Meeting held on April 3, 2025

Ms. Bailey presented the BOS meeting minutes. No changes were requested.

On a motion by Ms. Coram, seconded by Mr. Duffey, with all in favor, the Board approved the Minutes of the BOS Meeting held on April 3, 2025, for NatureWalk Community Development District.

### FOURTH ORDER OF BUSINESS

Ratification of the Operations and Maintenance (O&M) Expenditures for the Month of February 2025

Ms. Bailey presented the O&M expenditures for March 2025.

On a motion by Ms. Coram, seconded by Mr. Duffey, with all in favor, the Board ratified Operations and Maintenance Expenditures for the Month of March 2025, in the amount of \$60,853.52 for NatureWalk Community Development District.

### FIFTH ORDER OF BUSINESS

## **Staff Reports**

## A. District Landscape Provider

April services were completed as scheduled. Uniform shrub pruning and fertilization is complete.

Ms. Coram detailed an upcoming enhancement at Pond 21. Wax myrtle stumps and dead plant materials will be removed. Three trees will be installed on the southwest side of the pond and two trees will be installed on the north side.

Mr. Harrison confirmed the project is scheduled for May 2, 2025.

Green Earth provided a detailed map showing the sites of recommended shrub replacements at Ponds 13 and 15. The BOS had no questions and will consider the proposal during Business Items.

Green Earth provided the HOA with a proposal of NTE \$800 to add four additional sprinkler heads inside the Sports Courts fencing near the swing set. An area is not receiving adequate water due to the new fence placement, but the existing sprinklers must remain in place to irrigate District turf.

### B. District Engineer

Mr. Martelli presented a comprehensive review of the NatureWalk CDD Stormwater Operations & Maintenance Report to the BOS.

To support the longevity and functionality of the existing stormwater management facilities, this document provides an overview of current conditions and offers guidance for maintaining each system in accordance with its original design intent. It covers:

Stormwater Management Facilities: A detailed overview of each facility within NatureWalk, including its role in conveying and treating stormwater, along with design characteristics such as pond volumes, outlet control structures, weirs, and emergency spillways.

Operation and Maintenance Procedures: An outline of the actions required to promote performance and longevity of the stormwater infrastructure. This includes routine inspections, maintenance schedules, and corrective measures necessary to preserve the system's intended functionality.

- Ms. Coram inquired about inspections to maintain the functionality of the dry retention basin between Lovegrass and Chordgrass.
- Mr. Martelli explained this is a conveyance area and is not technically a stormwater management facility per the permitting documents, although it does contain pipes and inlets; he confirmed that the area will be inspected along with the wet detention ponds.
- Ms. Coram stated that the retention basin appears to be functioning properly now, but the turf is declining and Green Earth has recommended its future replacement. She asked if Innerlight would be part of that process to ensure the slope to the inlets is maintained.
- Mr. Martelli confirmed this is necessary as the biggest issue is to protect the inlets from sediments resulting from grass removal being introduced into the system as well as ensured the proper slopes to the inlets exist for positive drainage.
- Mr. Duffey asked if the piping underneath the gravel path that connects wetlands areas to its north and south would be inspected as there appears to be some debris present. This area is shown on the Stormwater Facilities 19 & 20 drawing 2-9.
  - Mr. Martelli confirmed that this would be included in the inspection scope.
- Ms. Coram asked if Innerlight has any information on the District well and irrigation pump system.
- Mr. Martelli can have an Innerlight engineer meet onsite with the District Chair to assist with gathering information, adding the equipment locations to the site map and generating an estimate for well replacement.

## C. District Counsel

Mr. Brown gave parcel updates.

Tracts G, I, K-1 Quiet title action: Court has issued a short pause order for lack of prosecution to dismiss the case; the hearing is in June.

Tracts J, K: owner is exploring development potential and debt settlement.

Tract E: no update on platting. The owner has been made aware of budget submission dates, after which no changes can be made to EAU or O&M assessments.

Discussion ensued regarding the need to reestablish emergency egress through Tract H. Ms. Coram asked if letters could be drafted to notify the Fire District and Walton County that NatureWalk requires access to the State Forest fire road so egress is considered when Tract H goes through the Technical Review and Planning processes.

Mr. Brown will reintroduce the subject with the Trustee Counsel as well since discussion will take place on May 1 regarding renegotiating the bond debt for Tract H.

## D. District Manager

Ms. Bailey deferred comment until later in the meeting.

## **E.** District Chair

Ms. Coram reintroduced the topic of installing additional gravel on District property and/or rights-of-way to better delineate zones that Waste Management vehicles may use to navigate the community's narrow alleys.

Discussion ensued. The topic will be reconsidered on June 5, 2025 to allow Waste Management to fine tune collection routes during the next several weeks. Ms. Coram will conduct an audit and provide the BOS with a map of problem areas.

Curb and sidewalk repairs will be conducted by Pat Shea Concrete LLC between May 5-16, 2025. Cones will be placed onsite.

Ms. Coram led discussion on District policy regarding trespassing and fishing on the inside of stormwater pond bulkhead platforms. Placing vertical signage around pond perimeters was ruled out in the past as it is impossible to locate signs to be visible to the public who approach from different directions and also to avoid sign fatigue.

Ms. Coram proposed a solution to install No Trespassing No Fishing signs on the bulkhead platforms that are accessible to the public. Signs would be affixed to the horizontal platform surface, so that they are visible only to trespassers. Ponds affected are #4, #12, #13, #14, #15 and possibly #22, #29. Discussion ensued.

On a motion by Ms. Coram, seconded by Ms. Head, with all in favor, the Board approved Trespassing No Fishing signs in an amount NTE \$150, for NatureWalk Community Development District.

SIXTH ORDER OF BUSINESS

**BUSINESS ITEMS** 

## A. Ratification of District Expenses

On a motion by Mr. Duffey, seconded by Ms. Head, with all in favor, the Board ratified Virgin Brothers and Green Earth Expenses for NatureWalk Community Development District.

# B. Discussion and Consideration of Green Earth Proposal for Ponds 13 and 15 Replacement Shrubs

Ms. Coram presented the Green Earth proposal.

On a motion by Ms. Coram, seconded by Mr. Duffey, with all in favor, the Board approved Replacement Shrubs for Ponds 13 and 15 in the amount of \$4,895.23, for NatureWalk Community Development District.

# C. Discussion and Consideration of SouthEast Straw Spring 2025 Pine Straw Installation

Ms. Coram noted that HOA pine straw application will begin May 5, with District install following immediately afterwards. The District Chair manages straw install to avoid upcharges. Ms. Coram will provide a site map to the SouthEast Straw crew chief prior to project start.

Funds are available in the FY24-25 budget; cost will be ratified at a later date as bale count is not yet available.

On a motion by Ms. Coram, seconded by Ms. Head, with all in favor, the Board approved District pine straw installation by SouthEast Straw in an amount NTE \$33,566.00, for NatureWalk Community Development District.

# D. Discussion and Consideration of Pond #13 Duck Complaint and Removal Requests

District Manager Holly Bailey stated that the CDD was made aware of a serious injury that took place due to the aggressive behavior of ducks placed in NatureWalk Stormwater Management ponds by humans. It was also reported that, as a result of their aggressive behavior, ducks have been kicked in an attempt to avoid further attacks.

Ms. Bailey consulted with the Florida Fish and Wildlife Conservation Commission (FWC), District Counsel and the District Insurance Provider, reviewed District policy and considered input submitted by residents.

FWC states it is illegal for humans to add Pekin and other domesticated ducks to ponds; residents and homeowners who do so are subject to fines. Scheduled feeding is also prohibited and subject to fines and citations. FWC confirms that duck feeding attracts other wildlife and since feeding certain wildlife is illegal, whether intentional or unintentional, fines also apply.

Per District policy, expert opinion, advisement from the District insurance provider and District Counsel, Ms. Bailey will act within her authority as District Manager to proceed with the safe removal of the ducks in accordance with any legal requirements.

# E. Discussion and Consideration of HOA Irrigation and Electrical Modifications at the North Entrance Sign

Ms. Coram notified the BOS that the HOA will be replacing the NatureWalk entrance signs that are situated on HOA and St. Joe property at CR395. Modifications to electrical and irrigation may be required; associated costs would be the responsibility of the HOA. As in the case of the Sports Courts irrigation modification, District vendors will be used.

Counsel advised that a formal agreement would not be necessary if District vendors are used and the HOA funds the modifications.

### SEVENTH ORDER OF BUSINESS

# SUPERVISOR REQUESTS AND AUDIENCE COMMENTS

There were no Supervisor Requests.

Ms. Tato asked for the name of the owner who kicked the duck recently and asked if the person had been reported to Florida authorities.

The name will be provided; Ms. Bailey notified FWC.

Ms. Tato stated that a duck had to be taken to a wildlife rehab center twice due to broken legs. She asked if the person(s) who injured it had been reported to the authorities.

The District Manager was not made aware of those two incidents.

Discussion ensued regarding duck safety and the refusal of the homeowners who brought the ducks to NatureWalk, as well as the group who is feeding them, to remove them.

- Ms. Tato questioned whether aggressive ducks pose a larger liability than the Stormwater Management ponds.
- Ms. Nace stated that the bigger problem is that animal cruelty is taking place and should be reported.
  - Ms. Tato stated she already knows who kicked the duck recently; she will report him.

District Counsel clarified that the CDD is not law enforcement; the District is responsible for maintaining its property. If people witness someone committing animal cruelty, it's up to them to decide whether the circumstances warrant, in their opinion, contacting law enforcement.

Mr. Brown stated that Stormwater Management Ponds are required infrastructure for NatureWalk. The District Insurance Provider assesses liability for CDD property and has not required fencing beyond what currently exists.

However, there is liability associated with the ducks' presence. The District does have an obligation to address them as they were placed on CDD property, have been identified as nuisance animals, and an injury has taken place.
